The following are the deficiencies identified by the FFC/Internal Committee at the time of Inspection. The College/ Management has to immediately fulfill the given deficiencies specified by the FFC/Internal Committee without fail within a period of 2 months, failing which the affiliation for the said academic year will be cancelled automatically.

- a) *New conditions have been imposed by the FFC/Internal Committee. Which are to be fulfilled in this academic year.*
- *Latest Fire safety Certificate.*
- b) *Subject to payment of all dues with regard to admissions made under 'Management Quota' in consultation with the University authorities and subject to final disposal of any Court Case and /or direction of any court order, if pending in any matter.*
- c) *Failure to settle the dues properly will entail the University to take up necessary action that deems fit in the matter viz. awarding punishments like levying heavy penalties; not permitting the college for semester and/or year-end examinations; and if necessary, disaffiliating the College, depending upon the severity of the issue-in-question.*
- d) *Subject to payment of affiliation in respect of other courses for which affiliation fee is not paid so far and subject to production of necessary documents and fulfillment of conditions stipulated therein.*
- e) *It is the responsibility of the College to pay the fees like IUT, Youth Festival, University Services Fee, Sports Affiliation Fee, and other prescribed fee and submit the challans to the University. It is also the responsibility of the College to have the amounts posted in the pass-book to be provided by University on payment of Rs.200/- into KrU Affiliated colleges Fee Collection A/c. No.31219802779 to validate their payments, or else, the payments will not be taken into cognizance.*
- f) *Subject to the condition that the College shall open a website with all the details pertaining to the academic and infrastructure of the College, if not already done. The website shall be updated at regular intervals.*
